RELEASE AND WAIVER OF LIABILITY

As a member of the Precision Valley Fish & Game Association with access granted to all properties owned by Precision Valley Fish & Game Association located in the Town of Weathersfield, VT, and being permitted to participate in activities of the Precision Valley Fish & Game Association, I agree to the following Release and Waiver of Liability which I have read and understand:

I, _____, hereby release the Precision Valley Fish & Game Association, their Officers, Directors, Members, and their agents from any liability, loss, damage, cost, claims and/or causes of actions, including but not limited to all bodily and personal injuries and death and property damage arising out of my use of the properties of the Precision Valley Fish & Game Association or participation in any and all Club activities.

I specifically understand that said activities include the operation and use by the undersigned and/or others of firearms and ammunition or archery equipment. This Release is given on behalf of me, my heirs, successors, executors, administrators and assigns.

Furthermore, I understand that these risk, hazards and dangers include without limitation:

- 1) The risk of handling firearms and being near others that have firearms in their possession.
- 2) The risk of injury from ammunition and shot from other guns.
- 3) The risk of exposure to hazardous materials, including but not limited to lead and mercury and other hazardous materials that may be present and inherent with the firing of ammunition.
- 4) The risk of injury from walking during and after inclement weather conditions.
- 5) The risk of injury from the use of various targets, backstops, structures, clay throwers and any other edifice that may be used at shooting ranges.

I understand the risk, hazards and danger of shooting and had the opportunity to discuss them with Precision Valley Fish & Game Association Officers and other Club members. I understand that these activities require a certain level of good physical and mental condition, and a degree of skill and knowledge to safely participate in these activities.

Furthermore, I acknowledge that:

- a) I understand that I have responsibilities too. Prior to actual handling or use of any handgun, rifle, shotgun or archery equipment on Precision Valley Fish & Game Association properties, I receive proper instruction/training in the use, safe handling and operation of such handgun, rifle, and shotgun or archery equipment.
- b) I agree to read and strictly follow all Precision Valley Fish & Game Association rules, posted at both the indoor and outdoor range facilities. I understand I can also review the Precision Valley Fish & Game Association rules on the club's Web site. I understand that any guest and family members utilizing my membership are my responsibility and that prior to entering any Precision Valley Fish & Game Association properties they have read and been instructed on all Precision Valley Fish & Game Association rules, and that they are FURTHER ADVISED of the content of this RELEASE AND WAIVER OF LIABILITY and that they must agree to it before I give them access.
- c) I agree to comply with all Vermont Laws while on Precision Valley Fish & Game Association properties.
